EFFECTIVE SEPTEMBER 16, 2019, BELOW IS A LIST OF REQUIRED FEES TO BE PAID UPON FILING CASES IN LOUDON COUNTY CHANCERY COURT, PURSUANT TO PUBLIC CHAPTER 429. THESE COSTS INCLUDE CLERK FEES, STATE LITIGATION TAX AND COUNTY LITIGATION TAX.

Unless otherwise specified, fees should be paid in advance. **Cost bonds will no longer be necessary.**

CATEGORY ONE CASES **\$324.50**
Contracts, Personal Injury, Property Damage, Malpractice, Wrongful Deaths, Employment Discrimination, Civil Rights Suits, Tax Disputes, Special Remedies and cases not otherwise specified.

CATEGORY TWO CASES **\$249.50**
Workers Comp Cases, Appeals to Circuit from general Sessions, City Court and other Courts or hearings; Transfers from Foreign Countries; Writs of Mandamus, Condemnation/Inverse Condemnation; and Quo Warranto Actions.

CATEGORY THREE CASES **\$199.50**
Adoptions, Legitimations, Paternity Cases, Termination of Parental Rights and other domestic relations matters not otherwise designated, Restoration of Citizenship, Name Changes, Minor Settlements, Enforcement Of Foreign Judgments, Orders of Protection (fees not required in advance)
